PERMISSION/RELEASE

Your youth's safety and welfare is YOUTH EMPOWERMENT CLUB("YEC") primary concern. However, your youth's participation in programs, trips, or activities offered by YEC (collectively "Programs") may involve risk. In consideration of participating in YEC Programs, I, on my own behalf and as parent or legal guardian of _____ ("Youth") and Youth's parents, heirs, assigns, personal representative, and estate, hereby agree as follows:

1. I acknowledge that participating in the Programs may involve known and unanticipated risks and may be inherently dangerous ("Risks"). These Risks could result in physical or emotional injury, paralysis or permanent disability, death, and damage to personal property. These Risks include dangers and hazards created by third parties and negligence of others. I understand such Risks cannot be completely eliminated, despite the use of safety equipment, safety training, and supervision, without jeopardizing the essential qualities of the Programs. My Youth's participation in the Programs is purely voluntary and my Youth elects to participate even with the Risks.
2. I hereby voluntarily release and forever discharge YEC and its directors, officers, employees, agents, volunteers, participants, and all other persons or entities acting for them (hereinafter collectively referred to as "Releasees") from loss, liability, damage or costs, including medical, court costs, and attorneys' fees, arising out of any illness, bodily injury, or death due to the Risks, Youth's participation in the Programs or travel related to the Programs. I FULLY UNDERSTAND AND AGREE I AM WAIVING ALL CLAIMS I MAY HAVE AGAINST YEC ARISING OUT OF ANY ORDINARY NEGLIGENT ACTS BY YEC, AND I AGREE I WILL NOT BRING A LAWSUIT AGAINST YEC ARISING OUT OF ITS ORDINARY NEGLIGENCE. I also agree NOT TO SUE the Releasees. This release does not apply to claims arising from intentional conduct or conduct that constitutes greater than ordinary negligence.
3. I further expressly agree to indemnify and hold harmless Releasees from any loss or liability they may incur due to Youth's participation in the Programs whether caused by the negligence of Releasees or otherwise.
4. I certify that my Youth is in good health, free from communicable disease, and able to participate in all activities. I further represent that my Youth has no medical or physical conditions which could interfere with my Youth's safety in the Programs, or assume all risks that may be created, directly or indirectly, by any such condition.

5. In case of emergency, I authorize YEC to obtain necessary medical treatment of Youth and release and hold harmless Releasees in the exercises of this authority. I further acknowledge and understand that I will be responsible for any and all medical and related bills that may be incurred on behalf of Youth for any illness or injury that Youth may sustain during the Programs or while traveling to and from the site for the Programs.

I agree that if any portion of this agreement is found to be void or unenforceable, the remaining portions shall remain in full force and effect.

PROHIBITED ITEMS

I understand that YEC may search my Youth or my Youth’s belongings while participating in the Programs if YEC staff suspects that my Youth possesses an item(s) that YEC staff believes jeopardizes the group’s safety or is against YEC rules, such as: electronics (cell phones, laptops, iPads, tablets or other devices), illegal substances, drug paraphernalia, vaping devices or paraphernalia, tobacco or tobacco-related products, weapons, alcohol, or stolen property (the “Prohibited Items”).

AGREEMENT TO TRANSPORT HOME

I understand that YEC may need to send a Youth home as a result of illness, injury, discipline problems, or possession of a Prohibited Item(s). I understand if my Youth is dismissed from the program, trip, or activity, my Youth will be transported home at my expense. (YEC will attempt to contact the parent or guardian to arrange such transportation.)

MEDIA PERMISSION

I give permission to YEC and anyone authorized by YEC to use my Youth’s face, likeness, voice and appearance for future representations of programs, activities, or trips.

I, on my own behalf and on behalf of Youth, hereby warrant that I have read this Release and Indemnification Form in its entirety and fully understand its contents.
